WHEREAS it is found necessary to
 Amend Oromia Rural Land Use Rent and
 Agricultural Activities Income Tax
 Proclamation No. 8/1995.

NOW THEREFORE in accordance with
 Article 49 (3) (a) of the state constitution it
 is proclaimed as follows:-

1. Short Title

This proclamation may be cited as
 “the Oromia Rural Land Use Rent and
 Agricultural Activities Amendment
 proclamation No. 64/2002.”
