PROCLAMATION No. 71/2003
A PROCLAMATION TO PROVIDE FOR THE ESTABLISHMENT OF THE OROMIA ETHICS AND ANTI CORRUPTION COMMISSION

WHEREAS, the Regional State and the People of the Region recognize that corruption and impropriety are capable of hindering the social, economic and political development of the Region;

WHEREAS, corruption and impropriety are to be checked in order to promote and sustain the development and the democratic process in the region;

WHEREAS, it has become necessary to create a society which shall not condone but rather be prepared to effectively combat corruption and impropriety;

WHEREAS, it has been deemed necessary to establish an independent government body capable of investigating and prosecuting, checking and preventing corruption and other improprieties as well as fighting corruption and impropriety through the promotion of ethical values in the society;

NOW, THEREFORE, by virtue of Article 49(3) (a) of the Revised Constitution of the Regional State of Oromia, it is hereby proclaimed as follows:

1. Mata duree gabaabaa

Labsiin kun “Labsii Komishinii naamusaa fi Farra malaammaltummaa Naannoo Oromiyaa Hundaessuuf bahe Lakk. 71/1995” jedhamee waamamuu ni danda’a.

2. Hiika

Akkaataan itti fayyadama jechichaa hiika biroo kan kenniisu yoo ta’e malee labsii kana keessatti:-

- 1) “Pirezidaantii” jechuun Pirezidaantii Bulchiinsa Mootummaa Naannoo Oromiyaa jechuudha.
- 2) “Komishinii” jechuun Komishinii Naamusaa fi Farra Malaammaltummaa Naannoo Oromiyaa jechuudha.

- 6) “Abbaa taayitaa” jechuun nama kamiyyuu mana hojii Mootummaa yookiin dhaabbata misoomaa Mootummaa keessatti itti-gaafatamummaan akka tajaajilu kan muudame, kan ramadame, kan qacarame yookiin ummataa kan filatame jechuudha.
- 7) “Hojjetaa Mootummaa” jechuun nama kamiyyuu seera bulchiinsa hojjetoota Mootummaa Naannoo Oromiyaaatiin yookiin seera hojjechiisaa fi hojjetaatiin yookiin seera of danda’e kan birootiin kan buluu fi mana hojii Mootummaa yookiin dhaabbilee misoomaa Mootummaa Naannichaa keessatti qaxaramee kan hojjetu jechuudha.

PART ONE

GENERAL PROVISIONS

1. Short Title

This Proclamation may be cited as the “Oromia Ethics and Anti Corruption Commission Establishment Proclamation No. 71/2003”.

2. Definitions

In this Proclamation, unless the context demands otherwise:

1) “President” means the President of the Regional Administrative Council of Oromia;

2) “Commission” means the Oromia Ethics and Anti-Corruption Commission;

3) “Commissioner” means the Commissioner of the Commission;

4) “Public Office” means any office of the Regional State the budget of which is fully or partially allocated by the Government and in which any Government activity is performed;

5) “Public Enterprise” means any regional public enterprise or share company the ownership of which is fully or partly owned by Regional Government;

6) “Public Official” means any official who is appointed, assigned or employed by the Government or elected by the public to serve in the Public Office or in Public Enterprise;

7) “Public Servant” means any person who is governed by the regional civil service laws or by Labor Law or by any other law and who is employed and working in the Public Office or in Public Enterprise;

8) “Sirnoota, Tooftaalee fi Qa-amolee Naamusaa” jechuun bulchiinsa Mootummaa keessatti haalawwan naamusaa gaarii hin taane sadarkaa ol’aanaan hir’isuu fi ga’umsa ogummaa fi haala gaarii ta’e ciccimsuuf kan tajaajilan tooftaalee, qaamolee, sirnoota yookiin ogummaawwan barbaachisaa ta’anii fi kan kana fakkaatan jechuudha.

3. *Daangaa Raawwatamummaa*
Kominishinichi dhaabbilee armaan gadii keessatti yakkoona malaammaltummaa ittisuu, qorachuu fi himachuuf aangoo ni qabaata:—
(a) Manneen hojii Mootummaa fi dhaabbilee misooma Mootummaa Naannicha keessatti argaman,
(b) Dhaabbilee dhuunfaa yookiin miti Mootummaa Manneen hojii fi dhaabbileen misoomaa Mootummaa Naannicha keessatti argaman kan keessatti hirmaatan.

4. *Ibsa Saalaa*
Labsii kana keessatti tumaan saala dhiiraatiin ibsame saala dubartiis ni dabalata.

5. *Bilisummaa Hojii Komishinichaa*
Labsii kana keewwata (6) keewwata xiqqaa (2) fi keewwata 11 keewwata xiqqaa (2)(G) jalatti kan tumaman yoo jiraataniyyuu komishinichi hojii isaa raawwachuu keessatti dhiibbaa namaa yookiin qajee-lfamummaa kamiyyuu irraa bilisa.

6. *Huundeeffamaa fi Itti Waamama Komishinichaa*

- 1) Komishiniin naamusaa fi farra malaammaltummaa Naannoo Oromiyaa kana booda “Komishinii” jedhamee kan waamamu qaama seerummaa of-danda’e kan qabu qaama mana hojii Mootummaa Naannichaa ta’ee labsii kanaan huundeeffameera.
- 2) Itti waamamni komishinichaa Pirezidaantii Bulchiinsa Mootummaa Naannichaatiif ta’a.

8) “Ethics Infrastructures” means mechanisms, bodies or procedures or the necessary conditions and similar matters that will serve to reduce substantially unethical conduct and to encourage efficiency and integrity in the public services

3. *Scope of Application*
The Commission shall have the power to prevent, investigate and prosecute corruption offences in the following institutions:

- (a) Public Offices and Public Enterprises found in the Region,
- (b) Private sectors and NGOs where by Public Offices and Public Enterprises of the Region Participate;

4. *Gender Reference*
Provisions of this Proclamation set out in the masculine gender shall also apply to the feminine gender.

5. *Independence of the Commission*
Notwithstanding the provisions of Sub-Article (2) of Article 6 and Sub-Article (2) (G) of Article 11 of this Proclamation, the commission shall be free from any intervention or interference by any person or organ with regard to the conduct of its operations.

PART TWO

Establishment, Accountability, Powers and Duties of the Commission

6. *Establishment and Accountability of the Commission*

- 1) The Oromia Ethics and Anti Corruption Commission (here in after referred to as “the Commission”) is hereby established as an independent Regional Government body.
- 2) The Commission shall be accountable to the President of the Regional Administrative Council.

7. **Kaayyoowwan Komishinichaa**

3) Yakka malaammaltummaa sa-axila baasuun, qorachuu fi hi-machuun Naannicha keessatti tajaajilli ummataa haqummaa qabu akka jiraatu carraaqii go-chuu,
4) Abbootii taayitaa fi hojjetto-ota Mootummaa Naannichaatiif kan tajaajilan dambiiwwan naamusaa adda addaa akka qophaa'an taasisuu, raawwattiinsa isaanii hordofuu fi danbi-wwan naamusaa qaamoleen biroo qopheeffataniif yoo gaa-fatame deeggarsa gochuu.

8. **Teessoo Komishinichaa**
1) Manni hojii ol'aanaa komishinichaa bakka teessoo Mo-otummaa Naannichaa ta'a.
2) Akka barbaachisummaa isaa-tti godinaalee Naannichaa adda addaa keessatti waa-jjirootni dameewwanii hundeeffamuu ni danda'u.

9. **Gurmaa'ina Komishinichaa**
Komishinichi:-
1) Pirezidaantii Bulchiinsa Naa-nichaatiin dhiyaatee Caffeen kan muudamu Komishinara tokko ni qabaata.
2) Hojjettoota hojichaaf barbaac-hisaa ta'an ni qabaata.

10. **Aangoo fi Hojii Komishinichaa**
komishinichi aangoo fi hojiiwwan armaan gadii ni qabaata:-
1) Waa'ee miidhaa malaammalt-ummaa irratti hubannoon um-matichaa akka cimu barsiisuu fi naamusni gaariin tajaajila ummataa fi hawaasicha keess-atti akka babal'atu gochuudhaan malaammaltummaa fi hoj-umaata gaarii hin taane balees-suu.

7. **Objectives of the Commission**
The Commission shall have the following objectives:
1) To strive to create an aware society where corruption will not be condoned or tolerated by promoting ethics and anti corruption education;
2) to prevent corruption offences and other improprieties;
3) To strive to create and promote integrity in public service by detecting, investigating and prosecuting alleged or suspected cases of corruption offences and other improprieties;
4) to cause the preparation and follow up the implementation of codes of ethics for public officials and public servants; and to assist others, upon request, in establishing their own codes of ethics.

8. **Head Office**
1) The Commission shall have its head office at the seat of the Regional Government.
2) It may establish branch offices in different Zones of the Region as may be necessary.

9. **Organization of the Commission**
The Commission shall have;
1) A Commissioner to be appointed by "Caffee" upon nomination by the President of the Regional Administrative Council; and
2) Such officers as may be necessary.

10. **Powers and Duties of the Commission**
The Commission shall have the powers and duties:
1) to combat corruption and other impropriety by creating awareness through educating the public about the effect of corruption and the promotion of ethics in public service and in the society;
2) to undertake research on ethics and corruption; give support to other similar activities and to publish reports and technical studies to further the purpose of the Commission;

- 5) Yakkoota malaammaltummaa seera yakkaa fi seerota biroo keessa jiran manneen hojii Mootummaa yookiin dhaabbilee misoomaa Mootummaa Naannichaa keessatti argaman yookiin Manneen hojii Mootummaa fi dhaabbilee misoomaa Mootummaa kan itti hirmaatan dhaabbilee dhuunfaa keessatti raawwatamuu isaniitiif eeruun yoo isa ga'e yookiin shakkii quubsa ta'e yoo qabaate qorannaa taasisuu yookiin akka qoratamu gochuu fi himata dhiyeessuu,

- 6) to inspect, search or seize, as may be necessary, any premise, working places, vehicle; or any property in accordance with the Criminal Precedure Code during the process of Investigation of offences related with corruption;
- 7. to detain, with out court warrant, persons, suspected of corruption offences for a period not exceeding 48 hours in accordance with the Criminal Procedure Code and to take fingerprints and photographs;
- 8. to summon, question and receive the testimony of persons and to order the presentation of any evidence from any person or office, in accordance with the Criminal Procedure Code and other laws, where it is found necessary for its investigation operations;

- 13) to provide physical and job security protection to witnesses and whistle blowers;
- 14) to ensure the preparation or to prepare and monitor the implementation of codes of ethics for Government Offices and Public Enterprises of the Region;
- 15) to establish and implement procedures and standards for the selection of awards, up on competition of persons or offices who are successful in fighting and preventing corruption;

(a) to direct, facilitate and administer the powers and duties of the Commission;

(b) to employ, administer and dismiss officers of the Commission in accordance with the terms and conditions of employment of the Commission to be issued in line with the basic principles of civil service laws of the Region;

(c) to prepare the annual work program and budget of the Commission and implement same up on approval;

(d) to effect expenditure in accordance with the approved budget and work program of the Commission and in accordance with the financial laws;

(e) to authorize, in accordance with the law, any officer of the Commission to carry out investigation or to arrest persons who are suspected or guilty of corruption;

(f) to issue warrants to search and obtain information therefrom, of any bank account of any person or organization if there is reasonable suspicion that such is relevant to case under investigation;

12. Term of Office and Removal from Office of the Commissioner

- 1) The term of appointment of the Commissioner shall be for six years, he may, however, be reappointed where necessary subject to the approval of the regional State Council "Caffee".
- 2) Once appointed, the Commissioner shall not be removed from his office unless;
 - (a) He is charged and found guilty of an offence by the court of law;
 - (b) He can no longer carry out his responsibilities on account of mental or physical illness.

13. Employment of officers of the Commission

- 1) The commissioner may employ such officers, on merit and integrity, as he thinks necessary to assist him in the performance of the duties of the Commission under this Proclamation.
- 2) The Commissioner shall exercise, following the general principles of the regional civil service law, the terms and conditions of employment of officers subject to the approval of the Regional Administrative Council.

14. Budget

The Regional Government shall allocate the annual budget of the Commission.

15. *Books of Accounts*

- 1) The commission shall keep complete and accurate books of accounts.
- 2) The Commission's books of accounts and financial documents shall be audited annually by the Region's Auditor-General.

Advisory Board

16. *Establishment of the Board*

There shall be established an Advisory Board (here in after referred to as "the Board" the members of which are the following:

- (a) The Commissioner;
- (b) The Directors of various Departments of the Commission;
- (c) The Region's Asuditor-General or his deputy;
- (d) The Head of the Region's Administrative and Justice Affairs Supreme Office;
- (e) The Head of the Region's justice Bureau or his deputy;
- (f) The Commissioner of the region's police Commission or his deputy;
- (g) The Commissioner of the region's "civil" Service Commission "or" his deputy;
- (h) One member of "Caffee" nominated by its speaker;
- (i) The Head of the Region's information and Public relations supreme Office;
- (j) The head of the region's Information Bureau or his deputy;
- (k) Representative of civil Societies appointed by the regional Administrative Council;
- (l) Office of public Administration and Zonal Affairs;

17. *Powers and Duties of the Board*

The Board shall have the powers and duties:

- 1) to advise the commissioner on the priority of measures to be taken to combat corruption and other unethical practices and to promote ethics education;

- 4) to receive periodic reports from the commissioner justifying the issuance of warrants to search or obtain information on bank accounts held by any person or organization under investigation; and to give the necessary advise as it deems it necessary;
- 5) to establish various committees from among its members as it may deem necessary for the effective and efficient performance of its functions and receive periodic reports from such committees;
- 6) to call experts as resource person necessary for its activities;
- 7) to advise the commission on the selection and awarding, upon competition, of persons or offices who are successful in fighting and preventing corruption;
- 8) to submit report, every six month, to the President of the Regional Administrative council which should out line in particular any advice given to the Commissioner; a summary of its activities, and high light problem areas with suggestions on how to resolve them;
- 9) to perform other similar activities assigned to it by the Commissioner.

- 4) There shall be a quorum where more than half of the members are present.
- 5) Decisions of the Board shall pass by majority vote; in case of a tie; the chair person shall have casting vote.
- 6. The meeting place of the Board shall be at the Head Office of the Commission.
- 7. With out prejudice to the provisions of this Article; the Board may establish its own rules of procedure.

PART FOUR

MISCELLANEOUS PROVISIONS

19. The Police and Prosecution power of the Commission

- 1) The investigation and prosecution powers of the Police and Public prosecutor specified under the criminal Procedure code and other laws are here by given to the commission with regard to matters specified in this Proclamation.
- 2) Public Offices and Public enterprises may; on their own initiatives; conduct investigations where there is reasonable suspicion that ethical violations or corruption offences have been committed. They must however, report the results of their investigations of serious ethical violations or corruption cases to the Commission before taking any decision.
- 3) Notwithstanding the provisions of Sub-Article (1) and (2) of this Article, the commission may delegate some of its powers and responsibilities to the region's Police and Public prosecutor as it deems necessary.

23. *Adabbii*

20. *Establishment of Ethics Liaison Units*

- 1) There shall be established Ethics Liaison units at every level of public offices and public enterprises the duty of which shall be to coordinate ethical issues and advise the heads of the concerned bodies.
- 2) The liaison unit shall be accountable to the head of the concerned government body; it may, however, cooperate with the Commission concerning its activities.

21. *Confidentiality*

Unless and otherwise ordered by court of law or concerned authority, any employee of the Commission is duty bound to keep in confidence all facts he/she comes to know while undertaking his duty.

22. *Duty to Cooperate*

Any person is bound to cooperate whenever cooperation and assistance is required by the commission in connection with its powers and duties.

23. *Penalty*

Unless it is punishable with more severe penalty under other laws;

- 1) whosoever attempts to influence, harm or punish or who influences, harms or punishes any person who gives evidence or provides information relating to corruption offences to the Commission, organs of judicial Administration, head of a Public Office, or a public Enterprise shall be punishable with rigorous imprisonment not less than three years and not exceeding ten years; and with fine not less than Birr three thousand and not exceeding Birr ten thousand.

- 2) Any official or staff of the Commission who abuses the powers and responsibilities legally entrusted to him shall, in addition to the forfeiture of any advantage gained there from, be punishable with rigorous imprisonment not less than five years and not exceeding ten years; and with fine not less than Birr three thousand and not exceeding Birr ten thousand.
- 3) Whosoever, with the intent to mislead the Commission or to injure others, submits a false report, allegation or evidence to the Commission shall be punishable with rigorous imprisonment not less than three years and not exceeding five years; and with fine not less than Birr three thousand and not exceeding Birr ten thousand.
- 4) Whosoever commits a deceitful act by pretending to be the staff of the commission shall be punishable with rigorous imprisonment not less than three years and not exceeding five years; and with fine not less than Birr three thousand and not exceeding Birr ten thousand.
- 5) Whosoever refuses to cooperate with the Commission as provided for in Article 22 of this proclamation shall be punishable with simple imprisonment not less than six months and not exceeding three years; and with fine not less than Birr one thousand and not exceeding Birr five thousand.
- 6) Whosoever obstructs or attempts to obstruct the activities of the Commission shall be punishable with rigorous imprisonment not less than two years and not exceeding five years; and with fine not less than Birr three thousand and not exceeding Birr ten thousand. Where the offence is accompanied by violence, the maximum penalty prescribed in this Sub-Article shall be imposed.

7) Whosoever having received summons or being called by the commission otherwise, refuses to appear or to give answer or to present documents or unwilling to be investigated with out good reason, within specified period of time, shall be punishable with rigorous imprisonment not less than one year and not exceeding three years; and with fine not less than Birr one thousand and not exceeding Birr five thousand.

8) Where the offences specified in sub-Article (1), (3), (4), (5), (6) and (7) of this Article are committed by juridical persons; the punishment with a fine shall be two fold.

24. Procedure and Rules of Evidence

Federal Proclamations No. 26/2001 shall be applicable to matters relating to procedure and rules of evidence.

25. Transitory Provisions

Any corruption cases or other cases related with corruption which have been committed prior to the coming in to force of this proclamation and the investigation of which have been just started, or undergoing, or finalized, or which have been in the process of trial, shall continue to be handled and decided in the same manner.

26. Power to issue Regulations and Directives

1) The Administrative Council of the Region may issue Regulations for the implementation of this Proclamation.

2) The Commission may issue Directives for the implementation of this Proclamation and the Regulations issued under this Proclamation.
